



## ***DIOCESE OF EL PASO TRIBUNAL***

Dear Petitioner:

The purpose of this questionnaire is to assist you in the initial step of presenting your case to the Tribunal. You are petitioning the Tribunal of the Diocese of El Paso to undertake an investigation of your marriage and to make a judgment as to whether or not the Catholic community considers you free to enter another marriage. We ask you to please complete this questionnaire as carefully and as completely as you possibly can. All the documents and information requested from you are important to the Tribunal, since it will be used to determine if your case can be accepted and what type of case you have.

Keep in mind that your submission of this form does not guarantee an automatic declaration of nullity of your marriage. If, however, a declaration of nullity is eventually granted, it will have no bearing on such things as the legitimacy of children, custody of children, child support, alimony, or visitation rights. These are natural and civil elements of marriage, and **this process deals exclusively with the religious and sacramental elements.**

The Tribunal process is governed by a detailed and strict procedural law of the Catholic Church. Most cases are completed in about ten to twelve months, but we could not guarantee that a particular case will be completed at a certain time nor that an affirmative decision will be handed down. If problems arise in getting testimonies or if we lose contact with you, your case may possibly be delayed. The Tribunal also sends all cases that receive an affirmative decision for confirmation to the Inter-diocesan Appellate Tribunal in San Antonio, Texas. Therefore **DO NOT SET A DATE FOR FUTURE MARRIAGE IN THE CATHOLIC CHURCH** while the Tribunal procedure is pending. These uncertainties often bring frustration and doubt that requires great patience. Please understand, however, that our painstaking attention to technicalities and the details required in the process are a sign of our great respect for marriage.

It is of utmost importance that you provide the Tribunal with the current and complete address of your former spouse, the **Respondent**. Since marriage involves two people and the Tribunal's decision will affect both parties, we cannot begin a case without information concerning both spouses. The Church's law requires that your former spouse be notified of these proceedings and be invited to participate as an equal participant. If your marriage did not occur in the ten counties, in Texas, served by the Catholic Diocese of El Paso, and if we are unable to learn the current address of your former spouse, we may not be able to accept your case. If you do not provide the Tribunal with the correct and current address of the Respondent, this may possibly delay your case. Hence, it is **YOUR RESPONSIBILITY AS PETITIONER TO PROVIDE A COMPLETE NAME, CURRENT ADDRESS AND TELEPHONE NUMBER** of your former spouse.

### **THE FOLLOWING MUST BE TAKEN INTO CONSIDERATION:**

1. All information given in reference to your case is strictly confidential.
2. Please type or **LEGIBLY PRINT** your answers. **Use black ink and do not use a pencil.**
3. Each party has the right to read and comment on each other's written statement so long as they both have submitted written statements to the Tribunal.

4. It is your responsibility to find at least three (3) witnesses, and to **OBTAIN THEIR CONSENT** to receive a questionnaire. They must answer it properly and return it to this office within the time period allotted to them. Their answers will be treated with utmost confidentiality.
5. If the judge finds that more information is needed, you will be asked to come to the tribunal for an interview or be physically present at a formal hearing held in the Tribunal court room on the date and hour designated.
6. If at any stage of the process you feel that your rights to a fair process have been violated, please contact the Judicial Vicar immediately. If for any reason you do not want for this Tribunal to process your petition, you may refer your case directly to the Roman Rota.

**THE FOLLOWING MUST BE SUBMITTED TOGETHER WITH THE PETITION:**

1. Recent Copy of Baptismal certificate. (Within the last 30 days.).
2. An authentic copy of marriage license (original or court certified).
3. Recent **court certified copy** of divorce decree. An original stamp/seal and/ or signature from the county court office is required.
4. Agreement to Tribunal Policies and Release of Liability.
5. One hundred dollars (\$100.00) initial fee - non refundable (part of the total cost of \$400.00). Under special circumstances and at the discretion of the judicial vicar, the petitioner may apply for cost reduction. **The amount agreed upon will have to be paid in full prior to the final hearing/session at first instance in El Paso, Texas and before the case is sent to the Inter-diocesan Appellate Tribunal in San Antonio, Texas.** If you decide to withdraw your case once the investigation has begun, the refund will be pro-rated, based upon how far along the investigation has proceeded.
6. A Photo of the couple. (Optional)

Finally, whenever you call our office, always refer to your case with the last name or maiden name of the petitioner (yourself) and the respondent (*e.g.* SMITH -DOE # 034-2020). In order to safeguard the demands of confidentiality, only the petitioner and the respondent can inquire as to the status of the case. If you need assistance in answering the questionnaire, please call the Tribunal so that we can connect with your parish Advocates.

**AGREEMENT TO TRIBUNAL POLICIES  
AND RELEASE OF LIABILITY**

1. I understand that, if the Tribunal accepts my case for consideration, it cannot and does not guarantee that an affirmative decision will be given. I also understand that the Tribunal will not promise or guarantee that the case will be concluded by a certain date. Because of this, I agree to wait until I receive a final decree in writing from the Tribunal before I set a definite date for remarriage within the Catholic Church.
2. Since I am petitioning assistance in personal matters from the Tribunal of the Diocese of El Paso, I, the undersigned, understand that it is necessary that personal information affecting me be made available to the Tribunal.
3. I understand that the Tribunal of the Diocese of El Paso, in the investigation of the case, may employ the services of a psychological professional or other expert witness and I hereby authorize the Tribunal to disclose complete information concerning my case to such professional for case review. I also understand that if the nature of my case demands the employment of such experts, I will be responsible for their professional fees. Upon completion of the case, I also authorize the Tribunal to release at its discretion information regarding the case to a psychological expert, counselor, priest or deacon for follow up counseling as well as for pre-marital preparation presently or in the future. It is understood that otherwise all contents of this investigation will be kept confidential, reserved exclusively to the parties to the case and to the staff of the Tribunal, according to the canon law of the Roman Catholic Church.

I hereby release all persons whom I have listed as witnesses or sources of information which the Tribunal requires, as well as all persons whom the tribunal may contact on its own initiative, from any liability to me or to any other person arising by reason of disclosure to the Tribunal of personal information or opinions affecting myself.

4. I understand that the Tribunal will take reasonable measures to preserve the confidentiality of any sensitive information disclosed hereunder. Accordingly, I agree to keep confidential any information that I shall learn in the course of the proceeding. Because all testimony in this case is given for the possible ecclesiastical annulment of my marriage, and because my interest is solely to present my case to the Tribunal, I agree not to use information that I may learn through the case in any other forum or for any other purpose. I also understand that neither the Tribunal nor the Roman Catholic Diocese of El Paso, Texas shall in any manner be responsible to me or any other person for any unauthorized dissemination of information which may occur.

I further agree to indemnify the Roman Catholic Diocese of El Paso, Texas against any and all liabilities costs, or expenses which may be incurred by, or claimed against, the Diocese as a result of any disclosures I may make, or cause to be made, related to my petition in personal matters herein.
